

Statements required in notice if the proposed tax rate exceeds the no-new-revenue tax rate but does not exceed the voter-approval tax rate, as prescribed by Tax Code §26.06(b-2).

NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.1837 per \$100 valuation has been proposed by the governing body of TEMPLE COLLEGE.

PROPOSED TAX RATE	\$0.1837 per \$100
NO-NEW-REVENUE TAX RATE	\$0.1752 per \$100
VOTER-APPROVAL TAX RATE	\$0.1838 per \$100

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for TEMPLE COLLEGE from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval rate is the highest tax rate that TEMPLE COLLEGE may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that TEMPLE COLLEGE is proposing to increase property taxes for the 2020 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 24, 2020 at 6:00 PM at Louise L Cox Board Room, 2600 South First Street, Temple, Texas .

The proposed tax rate is not greater than the voter-approval tax rate. As a result, TEMPLE COLLEGE is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Trustees of TEMPLE COLLEGE at their offices or by attending the public hearing mentioned above.

The 86th Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by TEMPLE COLLEGE last year to the taxes proposed to be imposed on the average residence homestead by TEMPLE COLLEGE this year.

Total tax rate (per \$100 of value)	\$0.1886	\$0.1837	3% decrease
Average homestead taxable value	\$125,187	\$135,036	8% increase
Tax on average homestead	\$236	\$248	5% increase
Total tax levy on all properties	\$9,035,509	\$9,952,822	10% increase
